


EDD Application Enhancement Overview

- Template validation
- Background validation & refresh
- Provides individuals record or bulk review configurations
- CSV support
- Upload by-pass
- Application updated to handle data types
- User Interface updates to make it easier to use



AOR Technical Overview



- Based on RBDMS 3.0 architecture
 - Focus on configuring EDD's in JSON
 - Supports 3.0 rules and SQL validation



EDD Configuration

- EDDs are configurable through a JSON config file
 - Field customizations
 - Masks, dropdowns, multi-selects, dates, look-up values from RBDMS RefCodes, text areas
 - Validation type and rules
 - Review requirement and review fields




Use in other States

- Implementation cost drivers
 - Configuration vs. customization
 - Number of fields in EDD
 - Number and complexity of validation rules
 - Customization of user interface (standard vs. advanced view)
 - Migration patterns (use product base tables or map to State specific backend database)
 - Custom security configuration
